

- ◆ There are two main type of expenses: **FIXED** and **DISCRETIONARY**
- ◆ In an **INCOME SHORTAGE**, you need to cut expenses, increase income, or use savings to balance your budget
- ◆ In an **INCOME SURPLUS**, you can increase your savings or increase your expenses to balance your budget
